1. Definitions

- **Cookies** – small text files stored on a user's device when visiting a website, enabling the recognition of the user's device or remembering user settings and preferences.
 - **Website** – all pages available under the domain www.wexopay.com and its subdomains.
 - **Controller** – the company **WEXO Solution s. r. o.**, which determines the purposes and means of processing data through cookies.
 - **User** – any natural or legal person visiting the website.
 - **Consent** – a freely given, specific, informed, and unambiguous indication of the user's wishes by which they signify agreement to the processing of data through cookies, as defined in Article 4(11) of the GDPR.

3. Legal Basis for Using Cookies

We process data collected through cookies in accordance with:

- **Regulation (EU) 2016/679** (General Data Protection Regulation – GDPR),
- **Directive 2002/58/EC** on privacy and electronic communications (ePrivacy Directive),
- **Act No. 452/2021 Coll.** on Electronic Communications (Slovak Republic).
- **Strictly necessary cookies** are processed on the basis of our **legitimate interest** (Article 6(1)(f) GDPR) to ensure the security and proper functioning of the website.
- **Analytics and marketing cookies** are used only based on your **consent** (Article 6(1)(a) GDPR), which you can withdraw or modify at any time.

4. Types of Cookies We Use

4.1. Strictly necessary (functional) cookies

Essential for the proper functioning and security of the website. Without them, some services (e.g., login, saving preferences, protection against attacks) may not function correctly.

4.2. Analytics cookies

Help us understand how visitors use the website (e.g., which pages are most visited, how users navigate), enabling us to improve content and functionality.


4.3. Marketing cookies

Allow us to personalize advertising, measure campaign effectiveness, and provide content tailored to your preferences.
